

# **Alimony and Child Support**

### **Course Description**

This course looks at the history of alimony and child support and the evolution of both concepts over time. The course covers jurisdiction - which courts can one go to for enforceable support orders. It also looks at federal and interstate support mechanisms and institutions that have been developed to make enforcing support orders easier.

### **Course Learning Outcomes**

At the completion of this course, students will be able to:

- Identify the variety of domestic relations laws that come into play when a marriage legally ends to determine the disposition of the marital property, the custody and support of any children, and the continuing financial support of one party by the other;
- Describe how and when a judge can terminate a parent's custodial rights to a child;
- Differentiate among the different types of spousal support;
- Identify and analyze the factors used in calculating spousal support;
- Describe how the federal government enforces child support orders across state lines;
- Articulate the categories of expenses that all states require when calculating child support.

#### **Final Exam**

Grades and credit recommendations are based solely on a final exam. When students are ready to take the final exam, they should register for a LawShelf account (or simply log in, for those with existing accounts). Go to the video-course page and click "Take the Final Exam" and pay the exam fee, where applicable. Students will be given instructions on how to take the exam. All exams are proctored by the Voice Proctor® proctoring system. An overview of the system is provided here and it requires no training or learning curve. Grades of 70% or above are considered passing grades and qualify for recommended transfer credit.

The final exam is based on the video course modules. Additional resources detailed in this syllabus are helpful for background and for building greater understanding of the course materials. #### **Case Studies**

Many LawShelf video courses include case studies. These do not necessarily teach new material but are meant to demonstrate how the materials covered in the course are applied by various courts. Concepts covered in the case studies are covered on the final exam; so watching the case studies is necessary before taking the exam. However, it is unnecessary to memorize the facts and details of the cases covered in these case studies.

### **Self-Quizzes**

Video-course modules and case studies feature self-quizzes that consist of practice questions on the materials covered in the videos. These questions are presented for the benefit of the student and are important to review before taking the final exam because they are similar in style and substance to the questions on the final exam. These quizzes are not graded or monitored and there is no record of how students answer these questions. Students may answer these questions as many times as they like and are encouraged to keep re-taking the quizzes until they have mastered all the questions.
