Business Operating Agreements

The Business Operating Agreements course consists of a series of reading and videowatching activities. It is assessed by a final examination.

Course Description

The Business Operating Agreements course de-constructs the process of preparing agreements that govern businesses, including corporations, LLCs and partnerships. It goes through the purposes of business governing agreements, discusses how to start the process and focuses on ensuring that agreements satisfy business needs and comply with applicable law.

Course Learning Outcomes

At the completion of this course, the student should be able to:

- Identify the purposes and effects of business operating agreements as they relate to various business forms including partnerships, corporations and LLCs;
- Determine which provisions should be included in business operating agreements in various situations;
- Apply various state and federal laws and regulations to determine which provisions are important to include in specific business operating agreements;
- Determine which jurisdictions and laws govern specific business operating agreements.
